

MEMORANDUM

To: Parents & Guardians
From: Strategic Partners Among Nations, Inc.
Re: Forms for Minors

Attached are copies of 3 types of forms that need to be signed by the parents and/or guardians of everyone going on a SPAN Church Planting Campaign who is younger than 18. Please follow the instructions below.

1. Campaign Contract

- Sign (*by both Parent/Guardian, and Minor*) 2 originals.
- Send both originals back to SPAN.

2. Campaign Release Form for Minor.

- Sign 2 originals and have them notarized.
- Send both originals back to SPAN.

3. Minor Travel Release Form.

- Sign 3 originals and have them notarized.
- Send 2 originals back to SPAN.
- Keep the 3rd original. Your youth/child should put it with their passport and take it on the SPAN campaign.

CAMPAIGN CONTRACT

(Send to SPAN)

By signing this contract, I am indicating that the minor would like to participate in a Strategic Partners Among Nations, Inc. ("SPAN") Church Planting Campaign, and we committed to obtain all of the funds necessary to do so. We realize that all funds that are obtained for this campaign are considered as charitable contributions to SPAN (*a non profit organization*), and therefore are the property of SPAN, for federal income tax purposes to the extent permitted by law. Tax deductible contributions will not be refunded.

We realize that all checks should be made payable to Strategic Partners Among Nations, and sent to 981 W. Arrow Highway #110, San Dimas, CA 91773, and that all funds will be administered as a personal "campaign account" in the minor's name for this campaign. We understand that this account will be established upon approval of the minor's application, and the receipt of a \$200 non-refundable deposit. SPAN may increase the price of this campaign upon notice to participants.

If the minor is able to participate in the campaign, the campaign price, established by SPAN, and any expenses incurred by SPAN on the minor's behalf for this campaign, will be deducted from the minor's campaign account. We will submit:

- 50% of campaign price (*after \$200 deposit*) at least 60 days prior to the campaign departure date; and
- All remaining campaign price at least 30 days prior to the campaign departure date.

In the event that campaign funds raised exceed the campaign price by \$200 or more, We understand that the minor may request such funds be applied as a non-refundable deposit toward a future SPAN campaign before the end of the next calendar year. These funds will be moved to a pending campaign account. No interest will accrue for funds left in a pending campaign account. Any funds not used by the end of the following calendar year will be used to further the mission of SPAN, and all records of the minor's campaign account may be discarded. In the event that campaign funds raised exceed campaign costs by less than \$200, such excess funds may be used, by SPAN, to cover other campaign costs.

In the event that the minor does not participate in the campaign, any expenses incurred for the minor or on the minor's behalf (*airline cancellation fees, deposits, etc*) will be deducted from the minor's campaign account, and we will be responsible for any deficit. We will pay any deficit within fifteen (15) days following notice to the minor of the amount of such deficit.
